GARAGE SALE PERMIT

The following excerpt from Section 27:5-8 and 27:5-16 of the Revised Statutes of the State of New Jersey governing roadside signs and outdoor advertising: *License and Permit required.*

A PERSON SHALL NOT ERECT, MAINTAIN OR MAKE AVAILABLE TO ANOTHER, A ROADSIDE SIGN OR ENGAGE IN THE BUSINESS OF OUTDOOR ADVERTISING, FOR PROFIT THROUGH THE RENTAL OR OTHER COMPENSATION RECEIVED FOR THE ERECTION USE OR MAINTENANCE OF SIGNS OR OTHER OBJECTS UPON REAL PROPERTY FOR THE DISPLAY OF ADVERTISING MATTER ON ANY STATIONARY OBJECT WITHIN PUBLIC VIEW WITHOUT FIRST OBTAINING FROM THE COMMISSIONER A LICENSE TO ENGAGE IN THAT BUSINESS AND A PERMIT FOR THE ERECTION, USE AND MAINTENANCE OF EACH SIGN OR OTHER OBJECT USED IN OUTDOOR ADVERTISING, EXCEPT AS PROVIDED IN THIS ACT N.J.S.A. 27:5-8.

A PERSON WHO ERECTS OR MAINTAINS A SIGN OR OTHER OBJECT FOR OUTDOOR ADVERTISING, OR AUTHORIZED HIS NAME TO BE USED IN CONNECTION THEREWITH, WITHOUT COMPLYING WITH THE PROVISIONS OF THIS ACT, OR THE REGULATIONS ISSUED THEREUNDER, SHALL BE LIABLE FOR A PENALTY IN AN AMOUNT OF NOT LESS THAN \$50 OR TO EXCEED \$500 FOR EACH OFFENSE. N.J.S.A. 27:5-16

PLEASE NOTE: Per Ordinance 33; Section 2. 1 – No person may conduct more than three (3) garage sales on his or her premises in any one (1) calendar year; *and* Section 2.2 - The sale set up shall not commence prior to 8:00 A.M., the actual sale shall not commence prior to 10:00 A.M., and the sale shall terminate by 5:00 P.M. Garage sale permits shall not be extended for more than a two day period.
